**ADOPTON OF THE ONTARIO COUNTY HAZARD MITIGATION ACTION PLAN**

At a regular meeting of the Town Board of the Town of Bristol, held at the town hall in said town, County of Ontario and State of New York on Oct 15, 2024, and a quorum of the Board being present, the following resolution was offered by Council Member \_\_\_\_\_ and seconded by Council Member \_\_\_\_\_;

**WHEREAS** the Town of Bristol recognizes the threat that natural hazards pose to people and property within the Town of Bristol; and

**WHEREAS** the County of Ontario has prepared a multi-hazard mitigation plan, hereby known as Ontario County Hazard Mitigation Action Plan in accordance with the Disaster Mitigation Act of 2000; and

**WHEREAS** Ontario County Hazard Mitigation Action Plan identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in the Town of Bristol from the impacts of future hazards and disasters; and

**WHEREAS** adoption by the Town Board demonstrates their commitment to hazard mitigation and achieving the goals outlined in the Ontario County Hazard Mitigation Action Plan.

**NOW THEREFORE, BE IT RESOLVED BY THE TOWN OF BRISTOL, NEW YORK, THAT:**

The Bristol Town Board adopts the Ontario County Hazard Mitigation Action Plan. This plan, approved by the community, may be edited or amended after submission for review, but will not require the community to re-adopt any further iterations. This only applies to this specific plan and does not absolve the community from updating the plan in 5 years.
